## **Properties Committee Update**

We continue to work on the process of selecting a facility for our religious education and social center. The architects we have selected, Weber, Murphy, Fox (WMF) from Erie, have assessed our facilities and earlier this month presented a preliminary report of the raw data to the Properties Committee on the feasibility and sustainability of the possible alternatives. The Committee met with WMF and noted that the report needed to give more attention to some renovations of the facilities that we indicated and in other cases went beyond what we needed at this time. The Properties Committee is studying the report in detail and will meet with WMF later this month to give us the data we presently need in the form that is most useable to aid us in making a decision. We are grateful to WMF for their professional advice and for working so closely with us to meet our needs.

## **Properties Committee Update**

Anne-Marie Welsh, the Director of Diocesan Communications for the Diocese of Erie, wrote an article last May summing up the status of the Pastoral Planning Process in the Diocese.

"It has been five years since the **first phase** of parish restructuring was implemented in the Diocese of Erie as a result of pastoral planning. At that time, through a series of mergers and partnerships, and after a significant process that included dialogue, feedback and refinement, the diocese reduced the number of its parishes from 117 to 96.

'Change is never easy,' says the Most Rev. Lawrence T. Persico, bishop of Erie. 'But it's encouraging to see that the majority of parishes have handled their transitions very well. The primary goal remains creating healthy, vibrant parishes where people can grow in their relationship with Christ.'

As Bishop Persico has said on numerous occasions, planning will be a way of life within the diocese going forward. To that end, a series of resources and options were created by diocesan administrators for those involved in a **second phase** of planning during which a number of parishes in several regions have been exploring the possibility of merging or partnering in the future.



While not as public as the first-round effort, this second phase of planning has been transparent within the communities involved, including the parishes of St. Agatha, St. Brigid and St. Mary of Grace in Meadville, that have now come together as one: the Epiphany of the Lord Parish.

Recognizing that a number of parishes in need of planning next steps would benefit from a more structured approach, Bishop Persico now has introduced a **third phase** of pastoral planning. The national Meitler organization already has been engaged, first to update key data that will be useful for planning in three deaneries [Bradford Deanery, the Oil City Deanery, and the West Erie Deanery], and secondly, to outline the steps that need to be taken to bring plans to fruition." (Bold added.)

In our own case, we are halfway through the architectural studies necessary to present an informed preliminary plan for the facilities to the parish. More to follow when we receive the completed study.

There have been numerous economic and demographic changes since the founding of many of our parishes in mid-19th through the early 20th century. Bishop Persico plans to engage the services of the Meitler organization to gather and analyze the data regarding these changes for *all* regions of the diocese to provide a factual basis for pastoral planning. The Bishop, priests, and the faithful are called to work together in this effort to build a strong and enduring future for the growth of the Catholic Church in Northwest Pennsylvania.

# Pastoral Plan: Properties Committee Update

As we mentioned in our first update, a Properties Committee was formed with the goal to explore how we can fulfill our mission as a parish in either the St. Brigid or St. Mary properties taken as a whole. A subcommittee of people representative of both parishes and involved in the usage of the two facilities was formed to develop a plan for how each facility could be used to hold the functions that are presently in both and what modifications or additions to them would be needed. This has been completed.

Our next task is commission an architectural firm to do feasibility and sustainability studies for each of the two plans seeking to ascertain short-term costs for modifications and long-term costs as we continue using one of the facilities. We are now in the process of securing such a firm.

## **Pastoral Plan: Properties Committee Formed**

Our first goal was to explore how we can fulfill our mission as a parish in either the St. Brigid or St. Mary properties taken as a whole. We sought input from our Religious Education and Youth Ministry personnel and people involved in major social activities to evaluate the potential of each property if we were to retain it as well as any changes required to enable it to accommodate our pastoral goals and continue all our activities.
